## SCHOLARSHIP 2020

### IMPORTANT GUIDELINES FOR SCHOLARSHIP 2020

The list of documents to be uploaded for Fresh Scholarships under Merit cum Means based scholarship scheme only are as under:

- i. Student Photo. (Mandatory)
- ii. Institution Verification Form. (Mandatory)
- iii. Income Certificate: Income Certificate issued by the Competent Authority in the State/UT Government is required (Mandatory).
- iv. Religion Certificate: Self Declaration/Certification or Self Attested Community Certificate - (Mandatory).
- v. Mark sheet:
  - (a) In case of Fresh: Self-Attested Certificate of 'Previous Qualifying Exam /Board Mark sheet' as filled in the Form. (Mandatory)
  - (b) In case of Renewal: Self-Attested Certificate of Previous Year /Last exam passed Mark sheet (for same/ongoing course) as filled in the Form. (Mandatory)
- vi. Fee Receipt of 'Current Course Year'. (Mandatory)
- vi. Proof of Bank Account in the name of Student. (Mandatory).
- vii. Residential/Domicile Certificate (Mandatory)
- viii. Aadhaar number of the student and if Aadhaar is not available then bonafide student certificate from the school/institute and scanned copies of bank passbook and Aadhaar enrolment ID (if applied for Aadhaar).
- ix. If School/Institute is located in a State/UT different from domicile State/UT of the applicant then bonafide student certificate from School/Institute.
